Supervises the housekeeping functions to maintain the general appearance and cleanliness of a facility. Plans, assigns and inspects the work of housekeeping employees. Trains housekeeping employees in the proper performance of duties. Coordinates readiness and availability of rooms with park desk personnel. Maintains inventory of cleaning supplies, linen and laundry. Prepares and maintains records and reports of housekeeping operation.

UNIQUE PHYSICAL REQUIREMENTS:

Work typically involves some lifting. May risk exposure to chemicals associated with cleaning supplies.

TYPICAL WORKING CONDITIONS: *Incumbents in the job will typically perform their job duties under these conditions.*

ADDITIONAL REQUIREMENTS:

Upon appointment, employees in this class may be required to maintain a valid driver's license and required to drive a licensed vehicle. This status may be necessary for the length of time in this class. If this is necessary it will be listed in the specific position description for that position. Applicants and employees in this job title may be required to submit to a drug screening test and background check. Applicants and employees in positions which perform job duties that may require contact with offenders in the custody or supervision of the Department of Corrections or with youth in the care, custody, or supervision of the Department of Juvenile Justice must meet qualifications pursuant to the federal Prison Rape Elimination Act, 28 C.F.R.115.17 and 115.317.
