Repairs and maintains automotive vehicles and equipment such as cars, tractors and trucks. Disassembles, repairs and assembles all systems, parts and related equipment such as engines, transmissions, hydraulic systems, brakes, electrical systems, etc. Maintains vehicles and equipment by repairing, adjusting or replacing batteries, tune ups, lights, fluids and lubricants, filters, belts, etc. Inspects and tests vehicles and equipment for necessity and completeness of repairs and servicing. Completes repairs and servicing reports. Operates tools and machinery in the repair and maintenance of vehicles and equipment. Assists in major repairs to all systems on major diesel powered equipment such as dozers, graders, backhoes, shovels, movers, cranes, loaders, rollers and pavers.

**UNIQUE PHYSICAL REQUIREMENTS:**

**TYPICAL WORKING CONDITIONS:** *Incumbents in the job will typically perform their job duties under these conditions.*

Work is typically performed in a garage or field setting.

**ADDITIONAL REQUIREMENTS:**

Upon appointment, employees in this class may be required to maintain a valid driver's license and required to drive a licensed vehicle. This status may be necessary for the length of time in this class. If this is necessary it will be listed in the specific position description for that position. Applicants and employees in this job title may be required to submit to a drug screening test and background check. Applicants and employees in positions which perform job duties that may require contact with offenders in the custody or supervision of the Department of Corrections or with youth in the care, custody, or supervision of the Department of Juvenile Justice must meet qualifications pursuant to the federal Prison Rape Elimination Act, 28 C.F.R.115.17 and 115.317.
